#### Creating conditions for the development of MSTH: The era of the revival of CHEMISTRY

In the context of the reorientation of the Russian economy and the course towards import substitution, the de-velopment of the segment of small- and medium-scale chemistry (MSTC) is of particular importance for the Russian industry.

The range of problems that MSTH producers have to face today haslong been known: the shortage of raw materials, thelack of a developed consumer market, personnel, the scientific component, the promotion of goods on the Russian market, infrastructure, and others.

- What kind of infrastructure is needed today to stimulate the development of MSTC?
- How to shorten the «customer path» in industrial construction and eliminate infrastructural constraints for MSTX producers?
- How to create a favorable information environment for the promotion of domestic products and services in the field of MSTH?
- How to establish interdepartmental interaction of all participants in this process?
- What is the role of youth and science in the development of MSTH?

### Made in Russia: perfumery and cosmetics. Russian brand - myth or reality?

Against the backdrop of sanctions and disruption oflogistics, retail chains and distributors had difficulties with the supply of finished cosmetics and raw materials from abroad to Russia.

But there was no shortage of cosmetics and perfumes on the market – Russian brands readily replaced foreign brands. However, having good flexibility in assortment, recipes and pricing policy, the domestic manufacturer is far behind the foreign ones in marketing: in packaging and advertising.

- Are there competencies in Russia to produce high-quality cosmetics?
- Can the consumer be sure of the safety of domestic products?
- How to help the Russian manufacturer and what measures of state support are the most effective today?
- How to create attractive packaging so that the Russian buyer does not turn away from the good quality and reasonable price of domestic cosmetics?


